VILLAGE OF CROSS KEYS SPRING PROMOTION OFFICIAL RULES

1. Eligibility

4. Random Drawing/Winner Notification/Odds of Winning

One (1) entry for the Promotion will be randomly drawn from among all eligible entries received during the Promotion Period to determine the potential winner of Promotion ("Winner"). Entrants need not be present to win. Odds of winning depend on the number of eligible entries received during the Promotion Period. Many will enter, few will win.

The Winner will be notified by phone or e-mail (in Sponsor's sole discretion) using the information provided at the time she/he entered the Promotion. In such event, the Promotion shall be conducted from among all eligible entries received prior to suspension, modification or cancellation, if any, prior to the date on which the event that compromised the affected Promotionand/or the Promotion Program occurred.
